1. Liability Waiver and Release: In consideration of the child named on this form (the participant) being allowed to participate in MMF’s Summer Programming, the participant’s guardian or parent, hereby release Manitoba Metis Federation Inc., and its trustees, directors, officers, servants, volunteers, representatives and agents from and against all claims, actions, demands, costs and expenses relating to injury, death, damage to person or property or loss of property, howsoever caused, arising out of or in connection with the participant taking part in MMF’s Summer Programming.
2. Photo/Video Release: Parent/Guardian authorizes MMF to take photographs and/or video of the child named on this form during program activities, and otherwise use these images, without charge solely for the purpose of promotional material in connection with MMF Summer Programming.
3. Medical Release: To the best of my knowledge, my child is in good health. I will notify the program, in writing, if my child is exposed to any infectious disease, or if any change in health status occurs during the three weeks (21 days) prior to the selected program session. In case of emergency, I understand every effort will be made to contact me. In the event I cannot be reached, I hereby give permission to the physician selected by MMF to hospitalize, secure proper treatment, order injection, anaesthesia or surgery for my child. In the event medication, medical advice, treatment and/or equipment are required, I agree to accept financial responsibility for fees in excess of provincial and/or private medical insurance.
